While Assistant Chief of the DOJ's Antitrust Division in New York, Ms. St. Matthew-Daniel supervised and prosecuted criminal antitrust cases, including collusion in public procurement in *U.S.* v. *G4S Secure Solutions NV* and collusion in labor markets in *U.S.* v. *Manahe et al.* In 2020, she served as Acting Director of the Division's Procurement Collusion Strike Force, and in 2019, as counsel to the Division's Assistant Attorney General. Earlier, she served as a trial attorney in the Washington Criminal II Section of the Antitrust Division (2015-2019), leading criminal investigations in parallel with civil conduct investigations by the Division, the FTC and the state Attorneys General; among others, she negotiated a deferred prosecution agreement and \$100 million penalty related to noncompete provisions in employment contracts in one of the few criminal antitrust enforcement actions ever brought against a healthcare provider.

Ms. St. Matthew-Daniel serves as co-chair of the Cartel and Criminal Practice Committee of the New York State Bar Association's Antitrust Section. She earned a B.A., with first class honors, from the University of Cambridge and an LL.M. from Harvard Law School, where she was a Cambridge/Harvard Law Link Scholar.
